The Journey of Asian American & Pacific Islander Heritage Month

In 1977, House Joint Resolution 540 and Senate Joint Resolution 72 were introduced to proclaim early May as Pacific/Asian American Heritage week—they both failed. The following year House Joint Resolution 1007 was passed and signed, which President Jimmy Carter codified as Public Law 95-419 on October 5, 1978. This established a 7-day period starting May 4, 1979, as "Asian/Pacific American Heritage Week".

In 1990, President George H.W. Bush signed Public Law 101-283 extending the week to "Asian/Pacific American Heritage Month". Two years later President Bush signed Public Law 102-450 which outlines major accomplishments and contributions of Asian/Pacific Americans. It was explained that the month of May was chosen to mark the anniversary of the transcontinental roadway completed in May 1869, and the recognition of the first Japanese immigrant in May 1843.

On May 1, 2009, President Barrack Obama signed Proclamation 8370 designating May as "Asian American and Pacific Islander Heritage Month" and implored the public to learn more about the history of Asian Americans. On April 30, 2021, President Joe Biden signed Proclamation 10189 reaffirming and continued the designation of May as "Asian American and Pacific Islander Heritage Month".

On June 13, 2022, President Joe Biden signed HR 3525 into law which will explore the creation of the first national museum dedicated to preserving the history, culture, and accomplishments of Asian Pacific Americans.

The purpose of the legislation would be to "(1) report recommendations for a plan of action for the establishment and maintenance of a National Museum of Asian Pacific American History and Culture in the District of Columbia; (2) develop a fundraising plan to support the establishment, operation, and maintenance of the museum through public contributions; (3) obtain an independent review of this fundraising plan, including an analysis

On April 28, 2023 President Joe Biden issued a Proclamation proclaiming "May 2023 as Asian American, Native Hawaiian, and Pacific Islander Heritage Month." Its more than a symbolic gesture, the White House not only recognizes the rise of hate crimes against the AAPI community but promised to help business owners with loans through the Small Business Administration

It's long overdue for there to be a centralized platform dedicated to acknowledging the significant contributions of Asian/Pacific Americans to our nation's infrastructure, and, more importantly, highlighting how our rich heritage has profoundly enriched the fabric of our nation.

 Instead of engaging in small talk, aim for more intimate conversations. Be open, vulnerable, and talk about common interests when meeting someone for the first time.

2. Help Others:

- Use networking as an opportunity to assist others. Consider what you're good at, what you're doing, and what others often seek your help with. Through my network, I have been able to connect individuals. I often get asked by students if I know anyone working in the XYZ practice area and I have tapped into my network either on LinkedIn or connected them personally through email.
- By offering value and support, you build stronger connections and contribute positively to your network.

3. Create Your Own Identity:

 Understand your strengths and confidently embrace your identity. Networking isn't always inclusive, but you can change the narrative by being authentic and proud of who you are.

4. Use Platforms, attend events, and join organizations:

- LinkedIn is one of the most powerful platforms to connect with others. Many have done away with the old method of sharing business cards.
- Attending networking events can also be a valuable tool. I know it might be often uncomfortable for many, but I haven't met a person who has left a bad taste in my mouth through a networking event. Be friendly, proactive in starting conversations, and find common interests to talk about.
- Joining organizations such as LAPA and NALA can expand your network.

Ignite & Transform: Unleashing Your Path to Success as a Paralegal in Today's Professional Climate

Maneuvering through the job market as a new paralegal grad can be confusing and overwhelming. As a new graduate in 2010, I thought I would land a paralegal position for a top firm in downtown Los Angeles, have an office on the 55th floor of the Arco Tower, and live my version of "Boss Babe in the City Paralegal Edition." This could not have been further from the truth. Three months after graduation, I landed a job in a collections law firm in Pasadena, California. I was in a little cubicle sorting out court filings that had been rejected. No glamourous receptionist was next to a beautifully arranged \$500.00 orchid arrangement as soon as you exit the elevator. From my cubicle, I could smell the strong scent of paint and the rustling papers and voices. There was no office on the 55th floor of a prestigious downtown Los Angeles law firm. I worked on the 4th floor of a legal collections firm in a bland, undecorated office next to a plethora of banker boxes full of court filing rejections. Fast forward to April 2024, I work for a woman-owned boutique law firm, where an abstract art piece of Ruth Bader Ginsburg hangs in the main conference room. The wall-to-wall white paint complimented the frame on the wall that read, 'Keep Calm and Litigate On". These fourteen years have been a ride, and if you read this until the end, you may learn a thing or two. If you are a new grad feeling discouraged, buckle your seat belt, and I will take you for a ride. I'm your paralegal auntie now!

Are you a bit nervous about what your future may look like in the paralegal field? Are you trying to find footing and sailing your proverbial ship into unknown waters? Guess what! We have all been there! We all have been new graduates. We all have contemplated our professional careers and had doubts. I have a notso-secret tip to tell you. It is normal. You are normal. It is easy to fall into confusion, so let me give you tips on creating a foundation for a successful professional life.

- Join a Community.
- Know Yourself.
- Know the Job Market.
- Be Brave and Ask Questions.

While at the University of La Verne, I was fortunate to be introduced to the Los Angeles Paralegal Association. I remember sitting in a classroom while I listened to this well-polished funny man with a sharp laugh introduce me to a community known as The Los Angeles Paralegal Association. He did not promise me riches and gold, but he gave me the keys to a source I have utilized for the last 14 years.

NETWORK! NETWORK! NETWORK!

Joining a community is an excellent way to learn about jobs, the job market, and the job itself. My paralegal colleagues often answered questions about procedures, pay, and which downtown law firms were hiring. Through the professional associations I joined, I have made some lifelong friends.

If you are an introvert or just plain shy, it is okay. You can find colleagues with whom you align and who will support your growth and be a beacon of light as you work your way through this thing called your professional life. Support through a community is a valuable resource that many new graduates fail to take advantage of. LinkedIn is a good way, but attending events and helping will help you get noticed. Attending an event can possibly lead you to your next paralegal position.

SELF-AWARENESS IS KEY!

Being a paralegal is your career; you are more than your career. Being a paralegal is part of you, but it does not define you. In any career, we need to be radically honest with ourselves. To be honest with ourselves, sometimes we should try things we do not want or are afraid of trying. My motto has been, "If you don't try it, how will you know?". We need to accept that employment offer in a legal collections firm with unattractive, bland, undecorated walls so we can learn from dealing with rejected court filings, which will be a resource for us in preparing documents in the future. Sometimes, what we do not want to do points us toward what we want to do. Sometimes, working with a solo practitioner is not for you because you prefer streamlined, established procedures in the office. If you do not try or do it, you will lack the mental capacity to measure your tolerance threshold. Also, auntie tip here: what we want changes as we go through the seasons of our lives. Be reflective and ask yourself the questions that will propel you forward.

THY MORE YOU KNOW THY MORE POWERFUL THY BECOMES!

This is the "stuffy" part of this article. Please don't fall asleep! I promise I won't. The paralegal job market is HUGE! You will find a paralegal position at \$24 to \$50 per hour. As a new graduate, you can expect between \$58,000 and \$72,000. In the middle of your career, you can expect between \$75,000 and \$85,000. Seasoned paralegals are in the \$85,000 to \$140,000 range. Paralegal managers have been known to be offered \$165,000 per year. This is all dependent on the area of law you decide to support and the geographics. Los Angeles tends to pay more than other metropolitan areas. Learning the market and being part of an association helps.

THERE ARE NO STUPID QUESTIONS

So, you got past the initial stage of an interview. What is next? There are three things I do during an interview. The first thing I do takes place before the interview; I learn about who is interviewing me, what area of law they practice, and their role in the interview process. The second thing happens during the interview. My best advice is to ask questions about the role and management's expectations. I also have the interviewers define their leadership style and how they motivate their support staff. Further, I ask followup questions to understand their law firm's culture.


There are no "stupid" questions, especially if you plan to spend 40 hours with the people who are interviewing you. The "Interview" is not unilateral. You are part of the process. You are interviewing them as much as they are interviewing you. The third thing I do is send a thank you card or email. I share the most significant moment and something I learned that resonated with me during the interview. This is something personal, and it keeps me in the hiring team's mind during the hiring process.

How does a first year college student network with professional legal recruiters and legal professionals? There has never been a better time to network than attending the LAPA Spring Career Conference. The Spring Conference allowed many students, such as myself, the opportunity to gain firsthand experience learning and networking with many successful legal professionals. Attending the conference allowed me to have a profound understanding of working as a paralegal alongside alternative career paths involving the legal field.

Legal recruiters Tracey Perkins, Kathy Ly, Scott Rosen, and Crystal Villa dove into what areas of law happen to be the most popular, as well as job concentration, visibility, and personal branding. Currently, commercial law along with labor, employment, and intellectual property law are the most popular fields. You can find the highest job concentrations in DTLA and Century City, followed by Newport, Orange County, and Irvine. If you're interested in increasing your visibility, legal technology skills in e-discovery and even AI have the ability to make you stand out among the crowd.

When it comes to personal branding, I've learned that there is no better way to market yourself than LinkedIn as it's essentially the instagram of the professional world. Following the legal recruiters panel, I learned what it means to be a certificated vs. being certified thanks to Elizabeth Garcia, Terri Walters, Ivan Zogovic, and Cheryl Garner. Once you receive your paralegal certificate, you can take a "mini bar exam" to become certified in fields such as e-discovery and NALA. A certificate has the ability to make you stand out from over 300,000 paralegals in the US to being in the top 8% that are certified and top 3% that have an advanced certificate.



With the advice of Felicia Vargo-Johnson, Adesh Singh, Allison P., and CJ Dolores, I was educated on career paths that explore new perspectives on the traditional paralegal role. Whether it's legal operations, AI, or state jurisdictions, there are many opportunities to work in alternate career paths.

My favorite event of the day was the networking event held at The Eight Bar as I was able to not only meet, but connect with each panelist that spoke at the conference. The environment was vibrant and everyone I met gave me new insight into the paralegal world. Given I was asked throughout the event for my LinkedIn, my word of advice after the conference is if you haven't already, make a LinkedIn account!


MEET UP WITH FRIENDS AT HOA

Table of Authorities/Table of Contents

The table of contents and authorities is simple, yet an important component of the brief, but it takes time to skillfully master this simple task. Fortunately, the version of our word processing software today has this feature built in. Moreover, I am sure there is other fancy software that does this. However, if you do not know how to use it or have the skills, you will not be able to create a professional looking table of contents and authorities.

With over 25 members in attendance, the multifaceted June Hunter of DISCO, Inc. gave an excellent presentation for the LAPA Upskilling Series the "ins-and-outs" of preparing table of contents and authorities. In just over 45 minutes, June was able to showcase simple yet helpful steps to set-up and prepare your word processing software for this task. The discussion started in a modest pleading word format where she emphasized the important use of the non-printing markers or formatting marks that can guide you throughout the document, such as breaks, spaces, paragraphs, etc. She showed which word processing menu options are most useful, like layout and reference menus to name a few. Then, she stressed making sure that the document format is properly done, headers are marked, and case cites, local rules and other authorities are properly cited to easily propagate your table of contents or authorities.

I have done several tables of contents and authorities for a motion brief, but this session solidified the knowledge that I already have while also highlighting new techniques that I can use. To those who are new to this, a new skill is unlocked. This informative session improved individual knowledge on a skill that is useful and relevant to our profession. See you at the next upskilling series for yet another interesting topic!

Your Car is Smarter Than You Think

After an airplane crash, we've

all heard about how quickly officials want to retrieve the airplane's "black box" to help them investigate the crash. But airplanes and trains are not the only vehicles that contain black boxes. On April 16, 2024, LAPA hosted another successful CLE, entitled "Exploring Crash Data Retrieval and Understanding the Black Box," presented by Elvis Desai, Senior Forensics Engineer at YA Engineering Services.

In 1994, General Motors ("GM") first included Event Data Recorders ("EDRs")—aka "black boxes"—in some of their passenger vehicle models, and it has since become the industry standard to include EDRs in motor vehicles. When vehicles are involved in a collision, these devices record invaluable data which allow analysts to determine such data as the rate of speed at impact, the direction each vehicle was traveling, and whether it was a "longitudinal" impact (in the front or back of a vehicle) or "latitudinal" (impact from the side). Analysts can then build models of the collision which can aid investigators in determining the cause of the crash, and can greatly determine the outcome of any possible settlement or litigation.

Mr. Desai holds a Master of Science degree in Automotive Systems Engineering with a specialty in Vehicle Safety from Kettering University, and is an expert in analyzing data from EDRs and Bosch Crash Data Retrieval (CDR) systems. LAPA is grateful to Mr. Desai for bringing his expertise on this fascinating topic to LAPA members through our CLE program. 


